

PVS – Strong fall in NPAT 2Q2022

PVS announced 2Q2022 consolidated business results with revenue increasing to VND3,812 billion (+24% YoY) and NPAT of parent company shareholders decreasing to VND12.1 billion (-92% YoY). The fall in NPAT was mainly due to:

- General and administrative expenses increased sharply (+54% YoY), in particular, labor and transportation costs.
- Gross profit margin decreased from 7.8% to 3.9% YoY. In which, gross profit margin of M&C segment (the main contributor to PVS's revenue) decreased to 0.4% from 5% due to a higher proportion of international contracts (Gallaf phase 2 & 3; Hai Long, Shwe) but usually give lower profit margin. In addition, the gross profit margin of most of the remaining business segments also decreased due to the increase in transportation and material costs.

With this result, PVS recorded 6M2022 with revenue of VND7,583.5 billion (+34% YoY) and NPAT of parent company shareholders at VND228 billion (-23% YoY).

PVS sets a target for the whole year of 2022 with revenue of VND10,000 billion and NPAT of VND488 billion, down 53.1% and 28% respectively compared to 2021.
