**On the Amendment of the Decision Approving the Establishment of a Securities Company
Branch**

Pursuant to Decree No. 155/2020/NĐ-CP dated December 31, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities, as amended and supplemented by Decree No. 245/2025/NĐ-CP dated September 11, 2025;

Pursuant to Government Resolution No. 66/NQ-CP dated April 7, 2026, on the reduction and simplification of administrative procedures and regulations relating to production and business activities;

Pursuant to Decision No. 686/QĐ-BTC dated February 28, 2025 of the Minister of Finance defining the functions, duties, powers and organizational structure of the State Securities Commission of Viet Nam;

Pursuant to Securities Business Operation License No. 06/GPHDKD dated June 29, 2000 granted by the Chairman of the State Securities Commission to ACB Securities Company;

Pursuant to Decision No. 07/QĐ-UBCK dated January 5, 2023 of the Chairman of the State Securities Commission approving the establishment of a branch of a securities company, whereby ACB Securities Company was approved to establish ACB Securities Company – Mac Dinh Chi Branch;

Based on the application dossier for the change of the Director of the Mac Dinh Chi Branch and the documents requesting the update of the Mac Dinh Chi Branch's address due to changes in administrative boundaries, submitted by ACB Securities Company;

DECIDES:
