The Company's charter capital increase shall be implemented in accordance with Resolution No. 2205/TCQĐ-HĐQT.26 dated 26 May 2026 of Asia Commercial Joint Stock Bank (the Owner), Members' Council Resolution No. 27/NQ-HĐTV-ACBS.26 dated 23 June 2026 of the Company, and the applicable laws.

3. The SSC requests the Company to carry out the procedures for amending its License for Establishment and Operation of Securities Business upon completion of the charter capital increase in accordance with Clause 9, Article 187 of Decree No. 155/2020/ND-CP dated 31 December 2020 of the Government detailing the implementation of a number of articles of the Law on Securities.
