DECIDES:

Article 1. Establishment of the insurance firm

Article 2. Capital

The charter capital of ACB Nonlife Insurance Limited Company is VND 500,000,000,000 (Five hundred billion Vietnamese dong), of which:

Article 3. Business lines, scope and place of operations

ACB Nonlife Insurance Limited Company is permitted to conduct the following business activities:

3.1. Business lines: Nonlife insurance and health insurance.

3.2. Classes of insurance and products:

3.2.1. Nonlife insurance:

- + Property insurance;
- + Cargo insurance;
- + Motor vehicle insurance;
- + Fire and explosion insurance;
- + Credit and financial risks insurance.

3.2.2. Health insurance:

- + Personal health and accident insurance;
- + Medical expenses insurance.

3.2.3. Term life insurance products with a policy term of one (01) year or less.

3.3. Permitted activities:



- 3.3.1. Conducting insurance business, reinsurance, and retrocession related to non-life insurance and health insurance lines;
 - 3.3.2. Investment of insurance funds;
 - 3.3.3. Provision of insurance auxiliary services;
 - 3.3.4. Other activities directly related to insurance operations.
- 3.4. Place of operations: Within the territory of Vietnam and other countries related to the permitted scope of operations in accordance with the laws of Vietnam and the laws of the relevant countries.
- 3.5. Customers: Domestic and foreign organizations and individuals in accordance with the laws of Vietnam.

Article 4. Term of operation

ACB Nonlife Insurance Limited Company is authorized to operate for a period of ninety-nine (99) years from the effective date of this License.

Article 5. Operating conditions

During its operation, ACB Nonlife Insurance Limited Company shall comply with the laws of Vietnam, the provisions set out in this License for Establishment and Operation, and the Charter of ACB Nonlife Insurance Limited Company.

Article 6. Effectiveness of this License

This License for Establishment and Operation shall take effect from the date of signing.

Within twelve (12) months from the date of issuance of this License for Establishment and Operation, ACB Nonlife Insurance Limited Company shall complete all procedures for commencement of operations in accordance with applicable laws and shall report the results of such procedures to the Ministry of Finance.

Article 7. Issuance of License

This License for Establishment and Operation is made in eight (08) original copies, of which: one (01) copy is issued to ACB Nonlife Insurance Limited Company; five (05) copies are retained by the Ministry of Finance; one (01) copy is sent to the People's Committee of Ho Chi Minh City; and one (01) copy is sent to the Department of Finance of Ho Chi Minh City.
